INTERNAL INVESTIGATION LEADS TO ARREST OF CENTRAL BUCKS TEACHER

This week, information was released to the public that former Central Bucks math teacher Michael London was arrested on charges stemming from inappropriate contact with a minor. London's employment was terminated by the District at the December 2022 Central Bucks school board meeting.

Central Bucks Superintendent Dr. Abram Lucabaugh released a statement regarding the case. He explained that the district previously brought Mr. London to the attention of the District Attorney's office, but that no charges were brought as the DA's initial investigation did not find any criminal behavior.

Dr. Lucabaugh then authorized an internal investigation, which brought to light additional evidence, and resubmitted the case to the District Attorney's office. It was at that time that the District Attorney investigated again, and determined that enough evidence existed to bring charges against London.

Currently, London is out on bail for Corruption of Minors, and will have his next court appearance at the end of this month.
