COMMISSIONER BOB HARVIE IN CAMPAIGN SPEECH AT PENNRIDGE SD: "COMMISSIONERS HAVE ZERO CONTROL OVER SCHOOL DISTRICTS"

At a political rally outside last Monday's Pennridge School Board meeting, organized by those seeking to "Stop Vermillion" curriculum review for progressive bias, Bucks County Commissioner Bob Harvie (D) gave a campaign speech. We think it's important to highlight some of the statements Harvie made, especially since he is seeking re-election this November, along with running mate and incumbent Diane Marseglia (D).

During his address, Harvie attempted to reassure spectators that his presence was "not just for political reasons." This admission shed light on the political undertones surrounding his appearance, and hinted at the ongoing undue influence of county politics in the context of local school board matters.

Yet, moments later, Harvie stated, "As county commissioners, we have zero control over school districts." The irony of Harvie making this statement on Pennridge School District property, himself a Levittown resident, is impossible to ignore. Beyond that, it is essential to note the fundamental contradiction his statement presents, in light of his actions as Commissioner.

In 2021, Commissioners Harvie and Marseglia enlisted their former political campaign manager to illegally override the COVID schools guidance written by Bucks County Health Director, Dr. David Damsker. They did this because they were under pressure from the Wolf and Shapiro administration, as well as from local Democrat activists. Their actions had a significant impact on Bucks County schools, caused a great deal of confusion, and resulted in over 80,000 students having to contend with mandatory masking and quarantine measures unnecessarily.

Bob Harvie and Diane Marseglia exerted an unprecedented degree of control over school district decisions when they usurped the authority to write medical guidance for students across the county.

Harvie's acknowledgment of his own political motives and the contradiction in his statements raise questions about the Commissioners continued interference in school district affairs. Commissioners Harvie and Marseglia, you do not indeed have control over local school districts, and your county politics has no place in communities where neither of you reside.
