BUCKS SHERIFF RAISES ALARMS ON CRIME AT PRESSER

Bucks County Sheriff Fred Harran has expressed growing concerns about the increasing crime rates in Bucks County since the pandemic.

Harran emphasizes that the issue is not a partisan one but notes Democratic Commissioners Bob Harvie and Diane Marseglia make claims of decreasing crime rates are misleading. They use statistics that compare pre-COVID days to COVID days when most people stayed home, resulting in fewer reported burglaries and car thefts. However, as the county transitions back to normal, crime is on the rise.

Furthermore, Harran highlights a new problem: the growing drug issue. He also points out a significant problem in the county's handling of individuals with medical issues, noting that the jail doesn't accept anyone with medical problems. This situation forces police officers to divert their attention to hospitals while a person gets cleared, potentially posing risks to the hospital environment.

Harran also disputes the claims of adequate funding for the sheriff's office. Although officials stated they provided \$1 million, Harran cannot locate the funds in his budget. The county's budgeting practices, according to Harran, are confusing and unconventional.

Harran is a 38-year law enforcement veteran, and he was joined at his presser by former Sheriff Milt Warrell.

Since March 2020, Democrat politicians and teachers' unions have been openly politicizing our children's education. Their influence led to school closures and mask mandates, which continue even in a post-COVID world. It's time for this politicization to stop.

A recent instance highlights this issue, involving political signs from the Democrat candidates running for the CBSD school board as CBSD Neighbors United. This gamesmanship has no place in a teachers' union and may strain the board-union relationship if a partisan leader takes Kirsche's place.

This is bad for teachers, bad for students, and bad for the district.
